- (b) any individual who is properly authorised in accordance with relevant CBH processes to access and use this Website and act on behalf of, and/or receive information about, a Grower (including its Account),

as applicable, as advised to CBH, and includes any Primary Contact.

- 2.1.5 **"CBH"** means Co-operative Bulk Handling Limited.

- 2.1.10 "Grower" means a grower/supplier of grain who as part of their farming business, delivers grain to a site owned, operated or managed by CBH for the purpose of receiving or storing grain throughout Western Australia or as designed by CBH from time to time and who is subject to the CBH Delivery and Warehousing Terms.

- 2.1.11 "Grower Service Centre" means the department that provides support services to Growers for all members of the CBH Group. The Grower Service Centre may be contacted by writing to Grower Service Centre, c/- Co-operative Bulk Handling Limited, GPO Box L886, Perth, 6842, by telephone on 1800 199 083 or by emailing growerservicecentre@cbh.com.au.
- 2.1.12 "PAN" is the Personal Access Number provided to an Authorised Contact upon registration.
- 2.1.13 "Password" is the password provided to an Authorised Contact upon registration, as changed by that Authorised Contact from time to time.
- 2.1.14 "Primary Contact" means an Authorised Contact who is authorised to appoint, remove and amend the authority levels of other Authorised Contacts for that Grower or Advisor, and has administration access to the relevant Account.
- 2.1.15 "Privacy Policy" means the policy on, and accessible from, the CBH Website. A copy of the policy may be obtained from Grower Service Centre.
- 2.1.16 "Related Bodies Corporate" has the meaning given in section 50 of the Corporations Act 2001 (Cth).

- 2.1.19 "We", "us" and "our" are a reference to CBH Group.
- 2.1.20 "Website" means the LoadNet® website accessible via the CBH Website.
- 2.1.21 "You" and "your" means you in your capacity as a Grower or Advisor, and/or an Authorised Contact, as the case may be.
- 2.2 Capitalised terms not defined in these terms and conditions have the definitions given in the CBH Delivery and Warehousing Terms.

3 ACCESS AND USE

- 3.1 In order to be able to access and use the Website, you must:

 - 4.3.2 posting a completed Change of Advisor Details form to: Grower Service Centre, c/- Co-operative Bulk Handling Limited, GPO Box L886, Perth, WA, 6842; or
 - 4.3.3 emailing a completed Change of Advisor Details form: growerservicecentre@cbh.com.au.

CBH reserves the right to follow up and make enquiries as to the veracity of any change request.

5 PRIVACY POLICY
