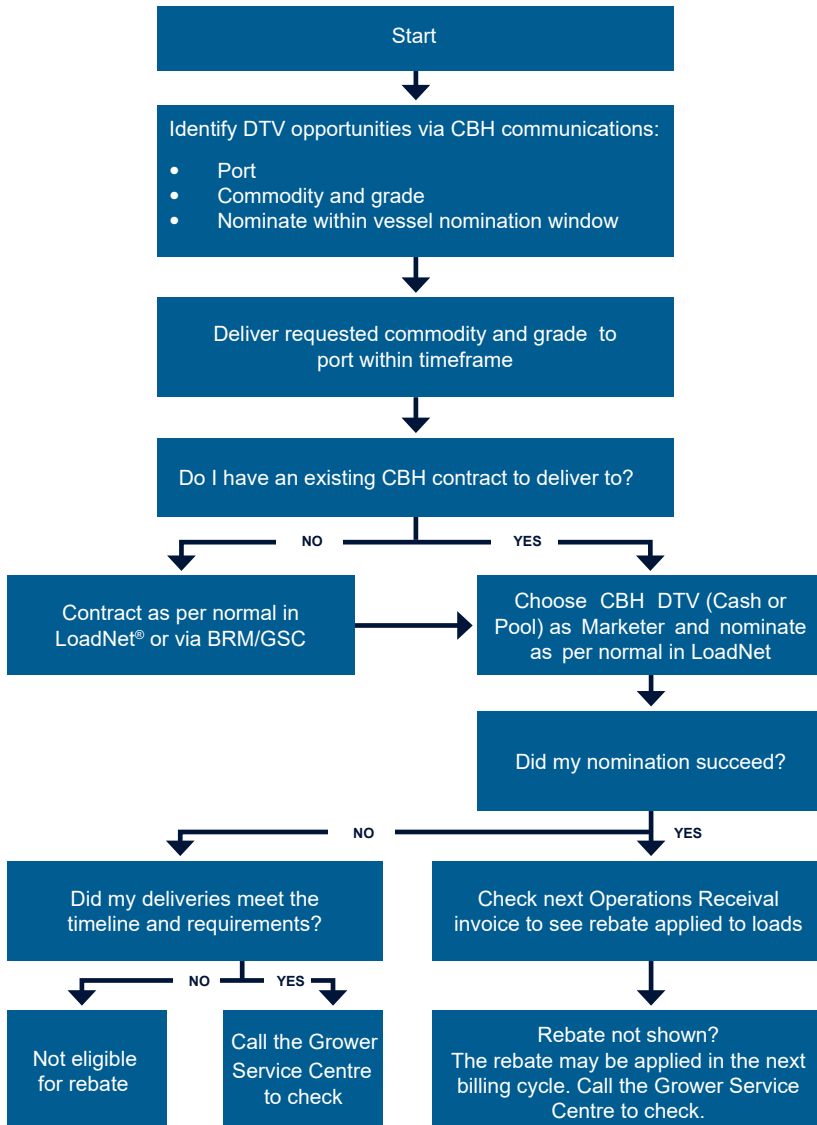


GROWER NOMINATION PROCESS

OVERVIEW

When nominating to the Direct to Vessel service in LoadNet, you must select **CBH Group - Cash - Direct to Vessel** or **CBH Group - Pool - Direct to Vessel** from the Marketer dropdown list. Nomination must occur within the nomination window specified for the selected vessel/commodity.

PROCESS

1. Sign to LoadNet and select the 'Nomination' tab from the menu ribbon.
2. To filter your deliveries, complete the Account Number, Season, Commodity and Zone from the dropdown options available.
3. Select the applicable **CBH Group - Direct to Vessel** option from the Marketer dropdown list.

4. After clicking the Select Loads button, select the loads to nominate as CBH Direct to Vessel. All Direct to Vessel loads must meet the delivery and nomination requirements to be eligible. It is recommended that Growers nominate as soon as possible after delivery to ensure compliance within the criteria and to ensure they don't miss out.
5. Complete the nomination as usual.

NOTES AND RESTRICTIONS

1. If you select loads for CBH Direct to Vessel (either Cash or Pool) and the nomination date is outside of the eligible window, the following message will display.

2. If Marketer limits are in use and the Grower nomination exceeds the limit, the grower will receive an error message on LoadNet. Nominations will not be processed above the limit set on the service. The Grower will need to reduce the nominated tonnes selected.
3. Overflow sites may vary in their availability. In the instance an overflow site has an active segregation for a DTV service and a delivery meets the requirements, 'CBH Group – Cash - Direct to Vessel' or 'CBH Group - Pool - Direct to Vessel' will show as available in LoadNet.
4. Share farms can participate in nomination to DTV when loads are transferred to one of the share farm participants accounts in LoadNet. Other grower-to-grower transfer loads are not eligible.
