Important Notes

The Nominated Estimated Pool Return (NEPR) is set at the start of the season, using market rates at that time, in order to establish a rate to pay growers during harvest. The 22/23 NEPRs were based on market rates prevailing on 23rd September 2022.

NEPRs should not be used as an indication of final pool return.

Current EPRs will be updated throughout the harvest.

Finance costs are the interest and financing costs associated with CBH Group's funding facility, used to pay growers before payment for sales made in the pool have been received.

New pool grades may be introduced throughout the harvest period where appropriate

Special Conditions

Non ISCC Canola delivered to the pool will be subject to a \$25 per tonne discount.

Snail grades CNS1 and CGS1 are applicable to Kwinana, Albany, and Esperance port zones.

For CNS1 in Esperance, premium may apply - current estimate is at \$30 premium compared to other port zones.

Quality Payments

Oil premiums start at 42% and are uncapped. A 1.5% premium or discount applies to the price for every 1% oil content above or below 42%, based on the clean seed value.
